# Support Services

## ***Academic Advising:***

Academic Advisors assist students in identifying educational and career goals, and developing a schedule of classes and individualized Student Education Plan (SEP). School transcripts are used to help in this process. An SEP helps ensure that students will meet all degree, transfer and/or certificate program requirements. Advisors will assist with the transfer process including college searches, scheduling campus visitations, and completion and filing of applications. ## ***Health Services:***

FRC provides limited health services to all its students through a special arrangement with the Plumas County Public Health Agency. Licensed health care providers are available and offer counseling, health education, assessment, and/or referral services. To receive services, students must show their FRC photo identification card with the current semester's validation sticker and they must make an appointment with the Plumas County Public Health Agency (530-283-6330). Students are responsible for all costs as a result of referral visits, including but not limited to prescription medications, lab tests, x-rays, and any hospital emergency room or patient fees. Students under the age of 18 must have parental consent to receive services, except family planning services, and must provide documentation of such consent before an appointment is made. ## ***Instructional Resource Center (IRC):***

## ***Library:***

The library is pleasant and comfortable with areas for group study and individual carrels for students to study or read for pleasure. Wireless capability throughout the library allows students with their own laptops to access the Internet. # **Cost of Attendance for 2023-2024**

In order to assist students and parents with making a more informed choice about the Cost of Attendance at Feather River College the estimated costs on the following page have been established. The cost of attendance for a student is an ***ESTIMATE*** of that student's educational expenses for the academic year. ***The table on the following page shows average expenses at FRC, rather than actual expenses.*** The following notes apply to the table:

1. Fees include Health & Transit fees, which are \$18 per semester for Health fee, \$1.50 per unit for Transit fee, and \$2 per semester or the Student Representation Fee. Fees based on full-time of 15 units per semester (which is the minimum load needed to graduate in 2 years). California residents: \$46 per unit; Out-of-state & International students: \$315 per unit (\$269 Nonresident + \$46 Standard Enrollment Fee per unit. Upper Division Coursework Fee: \$84 per unit.
2. The breakdown for this category is as follows: books (\$630), educational supplies (\$144), course material fees (\$180), and computer-related expenses (\$198), excluding the costs associated with the purchase of a personal computer.
3. On Campus dorm housing cost includes utilities, cable and WiFi; Parent and Off Campus housing costs include utilities.
4. Includes food, snacks, meals on campus, household supplies.

## Payment of Fees

**All tuition and enrollment fees are due in full by the first day of the semester.** If not, a payment plan outlining how the balance will be paid in full by the beginning of the 10<sup>th</sup> week must be signed by the first day of the semester, OR evidence that full payment will be made through Financial Aid or a waiver signed by the Chief Student Services Officer must be on file with Admissions & Records. A **HOLD** will be placed on the student's account by the beginning of the 10<sup>th</sup> week of the semester if payment in full has not been received. Also, billing statements will be sent following a regular, monthly schedule.

**All student housing fees are due according to the Payment Plan Option chosen by the student.** A **HOLD** will be placed on the student's account by the beginning of the 10<sup>th</sup> week of the semester for students who are not current with their housing payment. A late fee will be assessed as stipulated in the Student Application and License Agreement for housing fees not received by the Payment Plan due date.

A **HOLD** on the student's account prevents the student from enrolling in future semesters, obtaining official transcripts, and receiving their diploma until all balances owed to the College have been paid in full.

Student Accounts processes all student fees, refund checks, third party billing, and student housing fees. Students may pay fees through their Student Portal (MyFRC), in person with cash, check, Visa or MasterCard, or call 530-283-0202, ext. 292 to pay by phone. The Student Accounts office is located in the Admissions & Records office in the Student Services Building.

## FERPA

FERPA is a Federal law administered by the Family Policy Compliance Office in the U.S. Department of Education, 20 U.S.C. § 1232g; 34 CFR Part 99. FERPA applies to all schools that receive funding under any program administered by the U.S. Department of Education.

Once a student reaches 18 years of age or attends a postsecondary institution, he or she becomes an "eligible student," and all rights formerly given to parents under FERPA transfer to the student. The eligible student has the right to have access to his or her education records, the right to seek to have the records amended, and the right to have control over the disclosure of personally identifiable information from the records (except in certain circumstances specified in the FERPA regulations).

For a student to release their educational record and/or information to anyone, that student must have an *Authorization to Release Information* form on file with Feather River College stipulating with whom their educational records and/or information can be released. The records/information will only be released to those for which authorization has been given.

Awards for Pell Grant and/or Cal Grant (if awarded) reflect an amount based on 12 units or more. Units will be checked **7-10 days before** each disbursement date. *If you are enrolled/attending less than 12 units, your award amount will be adjusted.* Please refer to the Financial Aid Enrollment Policy for details. If your file is not completed and finalized 7-10 days before the disbursement date, an alternative disbursement date will be assigned. Also, your grants will not disburse until **your** classes have started.

\*Disbursement of the Cal Grant Award is contingent upon the receipt of the funds by the college.

Loan disbursement dates vary based on several factors:

- When the loan request form with all required documentation is turned into the Financial Aid Office
- When FRC completes processing of the loan and receives notification from the federal government that the student has completed the Entrance Counseling and the MPN
- Loans for first-time borrowers cannot disburse until you have been enrolled for 30 days in your first semester
- Loans for a single semester are required to disburse in two parts, the second disbursement occurs after the half-way point of the semester
- When you are enrolled in six or more units

**IMPORTANT NOTE:** Once we have originated your Direct Loan(s), the Disclosure Statement you receive from Direct Loans provides two dates that are NOT ACCURATE as to when you will receive your loan disbursement from FRC.
